TEAM CAROLINE A DAD'S PERSPECTIVE

We'd like to share a true story of hope about a group of people whose lives were impacted by CASA:

- Laura, Court Appointed Special Advocate (CASA)
- Caroline, teenager in foster care*
- John and Katy, foster and adoptive parents*

Here's a bit of our story. For starters, we never would've had a chance to be Caroline's parents without Laura. Laura was dedicated to ensuring our foster child had everything she needed. When she learned Caroline was unsafe in her prior placement, she used her unique role as a CASA to protect Caroline. After Laura informed the judge, the caseworker, and the guardian ad litem, Caroline came to our home.

Once Caroline was in our care, Laura became an invaluable resource. She spent a few hours with Caroline every week—getting boba tea, doing volunteer work, and generally just bonding and building trust. This was an incredibly valuable bit of stability for a girl whose whole life had turned upside down.

Laura didn't only advocate for Caroline—she also supported my wife Katy and me. Whenever we faced challenges, Laura helped address them so we could continue providing a loving home for Caroline. When we couldn't reach people on Caroline's team, Laura always answered the phone. Sometimes we were stressed and just needed to talk, and Laura was always there to listen.

Sometimes Laura saw we were overwhelmed with everything: court hearings, police contacts, school, therapy, and on and on, and she offered to take something off our plate. Other times, she took Caroline out so Katy and I had time to complete important tasks.

Laura's support made our lives easier, but it also allowed us to be the caregivers Caroline needs. We were all on "Team Caroline" together, so we made better decisions, which helped make Caroline a happier teen.

On July 7, 2023, Katy and I became Caroline's parents. Our adoption day was joyful, and Laura made it extra special. She brought cookies, flowers, signs, and a special scrapbook to the courthouse to celebrate our growing family.

We are so thankful for having a CASA volunteer to support Caroline, Katy, and me. Laura has truly been a godsend and has helped change three lives for the better.

Katy and I are not only forever on "Team Caroline" but also on "Team Laura" and "Team CASA." Thank you all for the wonderful and important work you do.

NEW! VOLUNTEER RECRUITMENT MIXERS

After a successful men's recruitment event earlier in 2023, CASA of Kent County staff realized an important truth: nothing helps break the ice like a slice of pizza!

Recruiting CASA volunteers is a tough business. Being a court appointed special advocate requires a level of dedication that's unique from many other volunteer opportunities. Often, new CASA volunteers report that they heard of CASA many years prior but took their time deciding when the opportunity was right for them. Both anecdotally and based on historical program data, CASA of Kent County staff members know that a word-of-mouth invitation is one of the most effective methods to find volunteers. And what could possibly be a better way to enhance the word-of-mouth recruitment experience than by serving pizza?

These mixer events bring together interested community members and friends-of-friends, allowing them to hear from current volunteers and ask all their CASA questions. The Mitten Brewing Company mixer in June of 2023 resulted in three men completing volunteer training in September. Following a coed mixer in September 2023, several prospective volunteers submitted applications. Two of them completed training in November, and others hope to attend training in March.

CASA of Kent County is excited to continue offering mixer events, both at The Mitten Brewing Company and new locations throughout 2024.







VOLUNTEER & DONOR SPOTLIGHT

Meet the Lemmons

Ron and Jeannine Lemmon have always been active members of the Grand Rapids community. Throughout their adult lives, both Ron and Jeannine have actively volunteered and served on several boards and committees. Over time, they found themselves being drawn toward direct, hands-on service roles where they could work with clients in the community.

Journey to advocacy

When the COVID-19 pandemic hit in 2020, Ron and Jeannine were no longer permitted to volunteer in the emergency department of a local hospital. They began looking for new ways to get involved and described their journey to CASA as "serendipitous." The Lemmons knew of CASA of Kent County and its mission from public service announcements on WYCE local public radio (another nonprofit where they volunteer). During their hospital volunteer hiatus, they each separately began considering the idea of becoming a court appointed special advocate. One day, Jeannine saw a Facebook post and mentioned the idea to Ron, when he'd been thinking about the same thing.

The Lemmons completed their CASA training in the winter of 2021. They learned about child welfare in Kent County and had an idea of what to expect, but during our conversations with them, Ron and Jeannine both emphasized the impact of their first advocate supervisor, Deb, in helping them learn the ropes. As their supervisor, Deb taught the Lemmons how to handle new and unpredictable situations as they arose and helped them hone their advocacy skills.


Two is better than one

As a husband-and-wife duo, Ron and Jeannine have the unique ability to split their time between their CASA children and have a higher capacity to visit them in different placements. Together and individually, they visit the four children involved in their case who live in separate foster homes in different towns. When asked about the role, Jeannine said, "I don't know how I would do this without him as a partner." Together, Ron and Jeannine are helping to ensure their CASA children's needs are met and that the kids are meeting developmental milestones. The best part about being CASA volunteers according to the Lemmons? Hugs from their sweet kiddos.

Beyond volunteering

In addition to their roles as advocates, the Lemmons support CASA of Kent County as both ambassadors and donors. Ron and Jeannine shared that, like their volunteer work, philanthropy has been a priority for them, and that they're drawn to small organizations like CASA that make a "lean and mean direct impact." The Lemmons support CASA with their own donations and by promoting CASA's mission in their personal networks, inviting friends to CASA events, and sharing about their work as volunteers.
