CASA Children and Teens

During fiscal year 2024, 599 children in Kent County lived in foster care due to abuse or neglect at home. Many of them were burdened by profound trauma and uncertainty and referred to CASA by concerned judges, attorneys, foster care workers, or foster parents.

Among these referrals was a toddler with bruises and scratches on her face and burns on her body, a young boy whose parents were unwilling to care for him anymore, and a teenage boy who experienced physical and sexual abuse and inadequate nutrition.

In an overwhelmed child welfare system, these children and others like them had the unwavering support of a Court Appointed Special Advocate. These caring adults stood by their side, spoke up for their needs, and helped guide them toward a safer, more stable future.



CASA Volunteers

Every day, CASA volunteers prove themselves to be extraordinary advocates to children in foster care. The CASA volunteer journey begins with a detailed application and interview process followed by 30 hours of specialized training and then a formal swearing-in before a 17th Circuit Court Family Division judge. CASAs choose their case and are assigned to a child or sibling group, often staying up to three years, supporting and advocating for them throughout the legal process.

These incredible volunteers are everyday people who have decided to make a difference in the lives of children in our community. In fiscal year 2024, they ranged in age from from 24 to 85 and came from a wide variety of personal and professional backgrounds. Some worked full time; others were retired; most had no prior child welfare experience. Their diversity made them even more effective, as all volunteers bring a unique perspective to their role, ensuring every child benefits from a compassionate and consistent advocate.

CASA Outcomes



For children removed from their parents due to abuse or neglect, the child welfare system is daunting. During fiscal year 2024, CASA volunteers worked closely with judges, attorneys, and social workers to protect the well-being of children and their families. While the main goal is to reunite children with their parents, other options, like adoption or guardianship are considered if going home is not possible. Sadly, some older teens "age out" without finding a permanent family. Sometimes, CASA needs to withdraw before the court case officially ends.

In fiscal year 2024, the court closed the cases of 66 children who had a dedicated CASA, marking significant progress in our mission to advocate for and support vulnerable children in our community.

Lauren & Rosa

A Child in Crisis

It was a cold day in November 2022 when Child Protective Services (CPS) visited the Jones home again in response to ongoing concerns about domestic violence and substance use in the home. Five-year-old Rosa answered the door. Her mother was inside, unconscious, and her father was nowhere to be found. CPS removed Rosa from her parents' care and placed her with her aunt and uncle, beginning her two-year journey through the foster care system.

A CASA Steps In

Nine months into Rosa's placement with her aunt and uncle, CASA volunteer Lauren joined the case to help assess Rosa's needs, monitor her situation, and advocate for her best interests. Lauren quickly became a trusted presence in Rosa's life.

Building Relationships

From their first meeting, Lauren and Rosa bonded over simple joys like building pillow forts, sledding, and spending hours outside. Sometimes Lauren would eat lunch with Rosa at school, and she often attended Rosa's school programs and performances, cheering her on from the audience. Rosa beamed with pride whenever she saw Lauren.

Beyond those moments of connection, Lauren worked closely with Rosa's aunt and uncle, parents, teachers, therapists, and caseworkers, making sure every decision prioritized Rosa's well-being. She regularly updated the judge so that Rosa's needs weren't overlooked as the case evolved.

Challenges

Despite Rosa's resilience, her parents' struggles with substance use and legal troubles made the case take longer than expected. Whenever one parent seemed to make progress, the other faltered. But through it all, Rosa thrived in her aunt and uncle's home. Her cheerful, talkative nature and developmental progress reflected the support she received from her caregivers and Lauren.

The Turning Point

With help from healthcare professionals and guidance from the judge, Rosa's mother turned her life around. She stayed sober, got a job, and moved into her own apartment. She reconnected with her church, which provided additional support and stability. As her situation improved, Lauren advocated for a gradual increase in the mother's visits with Rosa: moving from supervised to unsupervised visits and eventually to overnight stays.

Reuniting Siblings

Lauren played a vital role in reuniting Rosa with her older sister, Maria. Initially, Maria's father restricted visits due to safety concerns, but Lauren's persistence helped change his mind. Recognizing the mother's progress, he eventually allowed supervised visits at the aunt and uncle's home. These visits gave the sisters a chance to rebuild their bond, sharing laughter, conversations, and moments that deepened their connection.

By the end of the case, the sisters had overnight visits together with their mother, a joyful reunion that seemed impossible just months before.

A New Chapter

In November 2024, Rosa went home to live with her mother, marking the end of her time in foster care. The transition was a culmination of years of hard work and advocacy. Although Lauren occasionally checks in on the family, she knows her role as a CASA is complete. Rosa is back where she belongs, in the stable, loving home her mother worked hard to create.

Thanks to Lauren's determination and care, Rosa and her family have a second chance at a better future.
